Introduction:

The strategy and work plan of the Child Rights Commissioner at the National Institution for Human Rights (NIHR-BH) for the years 2024-2025, is based on the provisions of Law No. (26) of 2014 establishing the National Institution for Human Rights, amended by Decree-Law No. (20) of 2016, and the strategy and work plan of the NIHR (2022-2025), as the strategy of the Child Rights Commissioner came as a continuation of what was stated in the strategy and work plan of the NIHR-BH, which came in conjunction with the latter's creation of the position of the Child Rights Commissioner; as the NIHR-BH hopes that this will be a tool towards achieving further promotion and protection of children's rights in the Kingdom of Bahrain.

NIHR Vision and Mission

Introduction

The Kingdom of Bahrain has paid great attention to issues related to childhood, and this was reflected in the issuance of the Child Law (2012) and the Law on Restorative Justice for Children and Their Protection from Abuse (2021), in addition to the Kingdom's accession to the United Nations Convention on the Rights of the Child (1991), and the two Optional Protocols on the Involvement of Children in Armed Conflict and the Sale of Children, Child Prostitution and Child Pornography attached to the Convention (2004), in addition to its interaction in submitting national reports periodically and regularly on the progress made in implementing the provisions of that Convention and its Optional Protocols to the Committee on the Rights of the Child (CRC).

With the growing global interest in children rights, and in order to improve the human rights environment in national systems, the international contractual and non-contractual mechanisms of the United Nations concerned with human rights have called for the adoption of practical ways to ensure the adoption of more policies and measures aimed at strengthening and protecting child rights mechanisms, as the issue of the Commissioner for the Rights of the Child was raised in a number of recommendations of treaty bodies included in their reports and concluding observations on the national reports of the Kingdom of Bahrain, as stated in the reports of the Committee on the Rights of the Child (CRC) and the recommendations of the Universal Periodic Review (UPR) issued in 2022 and the report of the Committee on the Elimination of All Forms of Discrimination against Women (CEDAW), which prompted the NIHR-BH to study these observations and recommendations and move forward towards effective contribution to their implementation, as the NIHR-BH, through the powers contained in its law, established the position of the Child Rights Commissioner in June 2023, and on 11 July 2023, an official event was organized to inaugurate the position of the Child Rights Commissioner, in an official ceremony attended by many officials and ambassadors accredited to the Kingdom and representatives of civil society institutions, due to the utmost importance of this issue in preserving the best rights of the child and preventing any violations that may affect his life and upbringing.







First: The Competencies of the Child Rights Commissioner

The Child Rights Commissioner derives her role and the tasks assigned to her in the field of promoting and protecting children's rights from the same duties assigned to the NIHR-BH and included in its establishment law No. (26) of 2014, amended by Decree-Law No. (20) of 2016. The NIHR-BH hopes, through its creation of the position of Child Rights Commissioner, that it will be a tool towards achieving further promotion and protection of children's rights in the Kingdom of Bahrain, leading to excellence in achieving its vision and mission by making the culture of human rights a way of life that citizens and residents feel without discrimination, by involving everyone to achieve better practice of human rights.

The most prominent competencies assigned to the Commissioner for Children's Rights:

- (1) Representing the views of children and youth, and defending issues related to child rights.
- (2) Studying national legislation and verifying its compatibility with relevant international conventions.
- (3) Following-up on issues facing children, and working to protect and promote their best interests.
- (4) Conducting follow-up assessments of the impact of child rights on new policies and legislation.
- (5) Verifying any matter related to child rights, including the adequacy of complaints, support and assistance services provided to them.
- (6) Working to establish partnerships with government agencies, civil society institutions, and regional and international non-governmental organizations related to the rights of this group.
- (7) Conducting research and studies related to the rights, views and best interests of children.







Second: The Main Activities of the Child Rights Commissioner

(1) The efforts made by the Child Rights Commissioner in the field of promoting child rights

The provisions of Law No. (26) of 2014 establishing the NIHR-BH, amended by Decree-Law No. (20) of 2016, confirmed the role of the NIHR-BH in the field of promoting human rights, as Article No. (12) thereof approved a number of competencies for the NIHR-BH in order to achieve its goals in this field, including holding conferences, organizing seminars and educational and training courses in the field of human rights, conducting research and studies in this regard, participating in local and international forums, and in meetings of regional and international organizations, in addition to issuing bulletins, publications, statements and reports.

In implementation of the powers included in the provisions of the law, the Child Rights Commissioner plays an active role in promoting children's rights through a number of activities it has carried out, whether at the level of training or educational programs organized by the NIHR-BH, or those established by other entities in which the NIHR-BH participated effectively, in addition to participating and attending meetings, gatherings and visits with relevant national, regional and international entities.

(2) Efforts made by the Child Rights Commissioner in the field of protecting child rights

In implementation of the role assigned to the NIHR-BH and the powers granted to it under the establishment law, which grant it the right to follow up and monitor all issues related to human rights: political, civil, economic, social and cultural, which include children's rights. The position of "Child Rights Commissioner" was established to deal specifically with children's issues, receive complaints, provide assistance, and communicate with official and civil authorities, with the aim of protecting and promoting the best interests of the child, to ensure that children enjoy their full rights.

Fourth: Preparation, Partners and Stakeholders

- The Strategy of the Child Rights Commissioner was prepared in cooperation with NI-CO Northern Ireland Co-operation Overseas Ltd, in the United Kingdom, and the British Embassy in the Kingdom of Bahrain, during the period from (January 2023) to (May 2024).
- The Strategy was presented to a group of national experts, some human rights defenders, civil society institutions working in the field of childhood, and stakeholders for expressing opinions and advice on its axes and implementation mechanism.
- Official bodies represented by ministries, government agencies, public bodies and institutions, in addition to companies and private sector institutions, are key partners towards advancing the implementation of the strategic objectives of the plan, ensuring best practices that enhance children's rights.








Fifth: The strategic objectives of the Child Rights Commissioner
